We are located at, and are the managing partner of, the H.S. Lopez Family Foundation Center of Opportunity. We collaborate with over 50 partners and social service organizations to create a one-stop campus where guests can transition from homelessness to wholeness. This collaborative campus provides access to essential services such as medical care, dental care, mental health support, veteran's services, job training, and more.

GRM's Public Education and Volunteer Recruitment programs are designed to enhance public awareness of community needs and opportunities for volunteer services.

The breakfast is a time of fellowship and prayer to focus on the foundations of our faith, Christ's death, burial, and resurrection, and our unique response to the grace we received, reminding us to stand firm in our faith during these challenging times.
